3 section 2, clause 2 of the Constitution of the United States  
4 requiring that the treaty is subject to the advice and con-  
5 sent of the Senate, with two-thirds of Senators concurring.

6 (b) LIMITATION ON SANCTIONS RELIEF.—Notwith-  
7 standing any other provision of law, the President may  
8 not waive, suspend, reduce, provide relief from, or other-  
9 wise limit the application of sanctions under any other  
10 provision of law or refrain from applying any such sanc-  
11 tions pursuant to an agreement related to the nuclear pro-  
12 gram of Iran that includes the United States, commits the  
13 United States to take action, or pursuant to which the  
14 United States commits or otherwise agrees to take action,  
15 regardless of the form it takes, whether a political commit-  
16 ment or otherwise, and regardless of whether it is legally  
17 binding or not, including any joint comprehensive plan of  
18 action entered into or made between Iran and any other  
19 parties, and any additional materials related thereto, in-  
20 cluding annexes, appendices, codicils, side agreements, im-  
21 plementing materials, documents, and guidance, technical  
22 or other understandings, and any related agreements,  
23 whether entered into or implemented prior to the agree-  
24 ment or to be entered into or implemented in the future,  
25 unless the agreement is subject to the advice and consent

1 of the Senate as a treaty and receives the concurrence of  
2 two-thirds of Senators.
